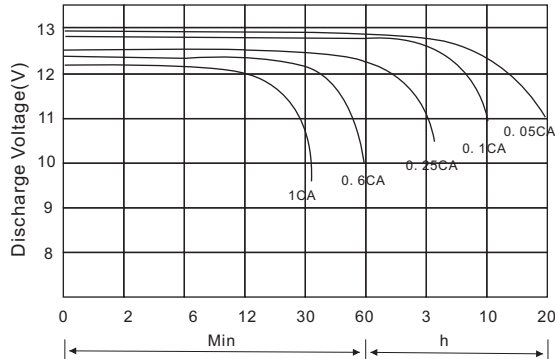

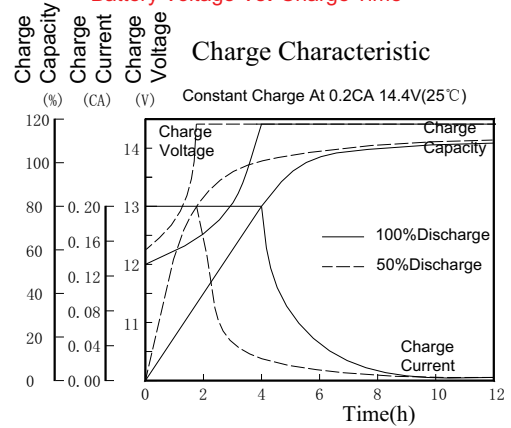

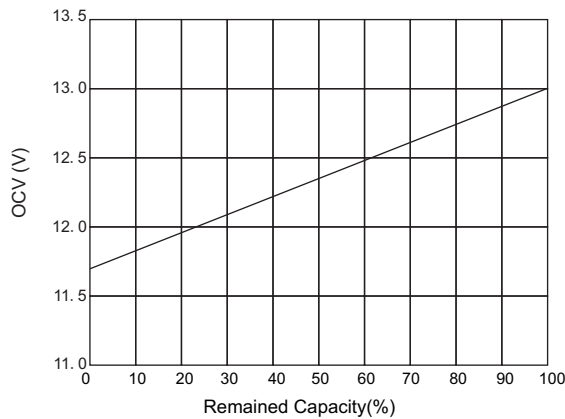
Terminal Voltage(V) Vs. Discharge Time (25°C, 77°F)



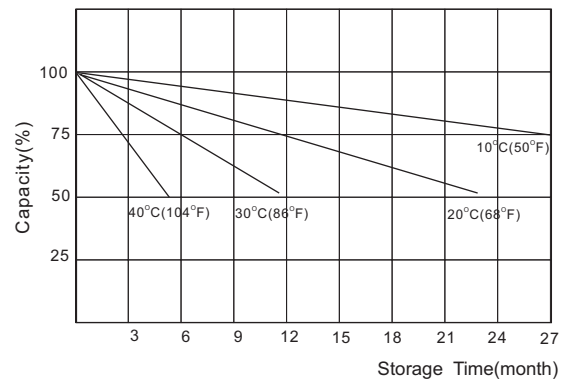
Battery Voltage Vs. Charge Time
